

Please vote" yes" to Amendment 2 on the ballot on Nov.8. It is to approve a constitutional amendment to create the "Safe Harbor for Sexually Exploited Children Fund." This is not a tax increase. The funds will come from additional penalties on convicted sex traffickers and allow assessments on the adult entertainment establishments. The fund would pay for care and rehabilitative for those individual in our state who have been sexually exploited. This will give our child victims of sex trafficking an opportunity to find a better life by providing safe housing and rehabilitative services.

The National Survey of Children's Exposure to Violence

found one in 15 children were exposed last year to intimate partner violence between parents or between parent and that parent's partner as quoted in the Ga Fatality Review. Many of these children will experience trauma from this exposure. Margaret Mead once said "Never doubt that a small group of thoughtful, committed citizens can change the world; it's the only thing that ever has."

November 8th is quickly approaching. Along with the 2016 Presidential election there are also four ballot measures for Georgia this year. Please research all of them carefully prior to heading to vote. Remember these are carefully worded Amendments and are worthy of being fully aware of both the pro's and con's of each.



On Nov. 8th Gwinnett County voters will go to the polls to decide whether to renew the one-cent SPLOST sales tax. The six-year program would start when the current program expires next March 2017. County and city officials have agreed to share SPLOST proceeds should the vote pass. This new SPLOST is estimated to raise \$950 million over the next 6 years with approx. 79% to be allocated for county use and 21% to be divided amongst the 16 incorporated cities in the county. The funds are earmarked for transportation improvements along with public safety, parks and recreation, library relocations and renovations, civic center expansion, senior service facilities, and city administrative, parking and cultural facilities plus city water and sewer capital improvements. There are currently over 900 potential projects on the Gwinnett County DOT

International Outreach is "wrapping up" the year in November so reports can be sent to the Dean Of Departments by 1 December. If you have any hours to report for activities that fall under IO but were not done with the IO group, please email them to Christine Peredney before the meeting on 3 November so they can be included in the 2016 report. Some of the activities could be international trips made, Individual contributions to international organizations, international art or music shows attended and volunteering at international events.

IO is collecting the Operation Christmas Child Boxes at the 3 November meeting. If you have an OCC box, please come with a filled container and a \$7 check for shipping. If you choose not to fill a box but are willing to bring some items that children may want or need, bring those items to the general meeting and a group will stay afterwards to pack them in OCC boxes. If you do not have a box, or desire not to purchase a plastic box, bring your items and there will be extra boxes for you to use. Be sure to include the \$7 shipping check, made to Samaritan's Purse and make the designation OCC. Be sure to designate on the box whether the gift is for a boy or a girl and the age of the child. Extra OCC instructions and tags will be at the meeting, if you did not pick one up at the last meeting. IO is partnering with Calvary Baptist and will leave the boxes and the checks for shipping with the congregation to take to the processing center. We are very grateful to the assistance Calvary Baptist has given us by furnishing us a meeting place. With two groups gathering OCC boxes, there will be a larger number of boxes to donate!

IO will also be collecting the pillowcase dresses made by club members to be sent to Little Dresses for Africa. The box has been packed with the 30 dresses that Janet Pino made and two dresses made by another member. We have room for at least 10 more! The dresses will be shipped out after the general meeting, in early November. The rest of IO's funds will be used to ship out the box.

Two hundred dollars from IO's budget and two hundred dollars approved by the LWC from general funds will be given to World Relief to purchase twin mattresses for refugees newly arrived in the USA, with almost nothing of their own. Thanks, members, for agreeing to help fund this project.

Thanks also for contributing food items to the Lilburn Co-op for World Food Day. These 66 items were taken to the Co-op and were appreciated. IO also is sending a check to the Co-op to purchase food from the food bank. It has been reported that some recipients are returning the donated food to the grocery stores to get cash for non food items. If you decide to donate food on your own, please mark through the bar code with a permanent black marker so canned goods and packaged foods can not be returned for cash. Most recipients are grateful to get help. Hopefully it is only a small minority that would abuse the food program.
